This notice describes our privacy practices. All these entities, sites, and locations follow the terms of this notice. In addition, these entities, sites, and locations may share health information with each other for treatment, payment, or health care operations purposes described in this notice.

OUR PLEDGE REGARDING HEALTH INFORMATION:

Stasia Petralia from Healing Naturally With Stasia understands that health information about you and your health care is personal. Stasia Petralia from Healing Naturally With Stasia is committed to protecting health information about you. Stasia Petralia from Healing Naturally With Stasia has created a record of the services you receive from us. We need this record to provide you with quality service and to comply with certain legal requirements. This notice applies to all of the records generated by Stasia Petralia from Healing Naturally With Stasia to service you, and any made by you. This notice will tell you about the ways in which we may use and disclose health information about you. We also describe your rights to the health information we keep about you, and describe certain obligations we have regarding the use and disclosure of your health information.

We are required by law to:

- Make sure that health information that identifies you is kept private;
- Give you this notice of our legal duties and privacy practices with respect to health information about you;
- Follow the terms of the notice that is currently in effect.

HOW WE MAY USE AND DISCLOSE HEALTH INFORMATION ABOUT YOU.

The following categories describe different ways that we use and disclose health information. By being a client to Stasia Petralia from Healing Naturally With Stasia, you give us the right to use your information for services, to get reimbursed for services rendered to you, and to operate Healing Naturally With Stasia.

- You authorize that your personal health information will be shared with Stasia Petralia from Healing Naturally With Stasia to create your health record and wellness plan, as well as other services that you may

purchase.

There are also various other ways in which we may use or disclose your information:

- As required by subpoena in lawsuits and disputes
- Various uses as required by law or to avert a serious threat to health or safety

OTHER USES OF HEALTH INFORMATION.

Other uses and disclosures of health information not covered by this notice or the laws that apply to us will be made only with your written permission. If you provide us permission to use or disclose health information about you, you may revoke that permission, in writing, at any time. If you revoke your permission, we will no longer use or disclose health information about you for the reasons covered by your written authorization. You understand that we are unable to take back any disclosures we have already made with your permission, and that we are required to retain our records of the care that we provided to you.

We may also use or disclose your personal health information for the following purposes:

- To contact you to remind you by phone, TXT or e-mail of an appointment for treatment or to contact you by mail or e-mail of the need for you to contact us about making an appointment.
- To contact you to describe or recommend alternative services that may be of benefit to you

Incidental Uses and Disclosures:

Incidental uses and disclosures of information may occur. An incidental use or disclosure is a secondary use or disclosure that cannot reasonably be prevented, is limited in nature, and that occurs as a by-product of an otherwise permitted use or disclosure. However such incidental uses or disclosures are permitted only to the extent that we have applied reasonable safeguards and do not disclose any more than is necessary to accomplish the permitted use or disclosure.

Examples include name and address to deliver practitioner supplements and herbs via postage services.

YOUR RIGHTS REGARDING HEALTH INFORMATION ABOUT YOU.

You have the following rights regarding health information we maintain about you:

- Right to inspect and copy
- Right to amend information you have supplied to us
- Right to an accounting of disclosures
- Right to request restrictions
- Right to request confidential communications
- Right to a paper copy of this notice Information on how to exercise these can be obtained from Healing Naturally With Stasia.

COMPLAINTS

If you believe your privacy rights have been violated, you may file a complaint with us or with the Secretary of the Department of Health and Human Services.
